

## **First meeting of the international selection tender panel**

### **Position of Assistant Researcher at LIP**

Minutes - February 3, 2026

These are the minutes of the first meeting of the international selection tender panel for the call of a position of Assistant Researcher to carry out research in the scientific areas of Instrumentation for particle/nuclear physics and technology applications to healthcare and space, and/or computing and information technologies, in the framework of the Agreement - Programme “Procedimento Concursal de Apoio Institucional – Laboratórios Associados” (articles 17, 19 and 28 of the Scientific Employment Regulations - *Regulamento do Emprego Científico - REC*), signed between FCT and LIP.

The call was open from 10<sup>th</sup> December to 31<sup>st</sup> December 2025, 17:00 (Lisbon time).

The panel meeting took place over Zoom on February 3, starting at 09h00 and ending at about 10h00 (Lisbon time).

#### **1. Conflicts of Interest**

No conflict of interest was identified.

#### **2. Exclusions**

Following the tender procedures (Section 4), the panel considered first the admission and exclusion of applications, according to the requirements outlined in Section 6. All applications (5) were admitted, since each one of the five (5) candidates had a PhD in the scientific areas of the call and a scientific and professional curriculum whose profile is suited for the activities to be performed. The decision was taken by unanimity of the jury members present.

#### **3. Assessment and ranking of the admitted candidates**

In the assessment and ranking of the admitted candidates, the jury considered specifically


- a) the scientific, technological production deemed most relevant by the candidates.
- b) the adequateness of the candidate's profile and of his/her motivation letter to the development of the activities related to the LIP research lines mentioned above.

The members of the panel present at the meeting unanimously considered that the five (5) candidates, Luís Margato, Marco Pinto, Mário Sousa, Paulo Braz and Ricardo Peres, here listed in alphabetical order, should be equally ranked at this phase in the criteria above mentioned, and selected to pass to the next step of this tender.

At the end of the meeting, the panel mandated the chair with the elaboration of these minutes, that were reviewed, revised and agreed to by all panel members.




